# **Britain's Oaks are under threat!**

## Please help Woodland Heritage support the vital research required into Acute Oak Decline (AOD)

In June 2011, Woodland Heritage launched an urgent appeal to fund vital research into the causes of **Acute Oak Decline (AOD)**. Despite massive increases in our understanding of AOD, this disease continues to demonstrate a huge potential threat to the future of our iconic Oak. Its place in our historic countryside just cannot be ignored!

Through our efforts to support the multi-disciplinary approach of Dr Sandra Denman at Forest Research and the many scientists she works with across a host of universities, great progress across many fronts has been made over the last eight years. This has included revealing the complex links between an array of bacteria (some new to science) and the *Agrilus* beetle that has a statistically significant relationship between its presence and affected trees, as well as a variety of other, important factors.

The latter factors all contribute to putting our oaks under stress, thereby reducing their resistance to AOD and include a changing climate, drought and waterlogging, ground compaction, and the pollutant deposition. Nutrient deficiencies in soils are also being linked to susceptibility to AOD. Understanding the threats helps with the management of our oaks, thereby reducing the risk of AOD that they face now and in the future.
